### BOOKS, SUPPLIES, STATE TESTS, and TECHNOLOGY FEES / DEADLINE IS JULY 23:

- K5—2nd: \$550 per child (includes all curriculum books and labs)
- 3rd-8th: \$600 per child (includes laptop rental - to be turned in at end of school year. If not turned in by the deadline, a \$175 fee will be charged.)
- 9th-12th: \$625 per child (includes laptop rental - to be turned in at end of school year. If not turned in by the deadline, a \$175 fee will be charged.)

Parents must rent the laptop through TLCA for students in grades 3rd-12th as we will be using Abeka Master Video curriculum. (TLCA uses Abeka for K5-12. One of the many reasons we use Abeka is because of the engagement aspect of this curriculum. Lessons are expertly taught with video instruction — from a Christian perspective — for every subject & grade and recorded in a master teacher’s actual classroom at Pensacola Christian Academy. Students feel like part of the onscreen class. They see their “classmates” learning, making mistakes, and improving—just like they are. We then, also, provide a well-managed classroom environment with certified, in-class teachers who oversees classwork, quizzes, and tests. Students watch the lessons, learn along with their classmates on video, and participate in assignments, activities, and games.)

UPDATED (1/30/25) STUDENT DRESS CODE AT-A-GLANCE



- Polos purchased through TLCA - available in black, gray, navy, and red.
- Other shirt options will be available throughout the year: TLCA t-shirts, 3/4 zips, and sweatshirts.
- Khaki/Twill pants can be any solid color and style.
- Any style of shoes are allowed, \*except\* for flip-flops, slide-ons or excessively high heels.
- No hats or hoodies on head inside the school or inside buildings on field trips.
- Khaki/Twill shorts are allowed for K5-5th grade and should be knee-cap length.
- Ladies may wear skirts (with the uniform TLCA polo) of any solid color and should be knee-cap length or longer with shorties, biker shorts or leggings worn underneath.
- We recommend solid color sweaters, light jackets, cardigans, or zip up hoodies on cooler days.
- No clothing with logos (other than the TLCA logo) will be allowed at any time.
- Male students' hair should not cover eyes or drop below the collar.
- Female students' hair should not cover eyes.
- Excessive piercings are not allowed, i.e. nose rings, lip rings, multiple earrings in one ear.
